Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a **scanned copy of the bid security in pdf format** amounting to a minimum of **as mentioned above in the table for particular packages**, which shall be valid for 30 days beyond the validity period of the bid.

Bidders needs to submit the copy of Firm/Company Registration Certificate, VAT registration Certificate and permanent account number (PAN) registration certificate, Tax Clearance Certificate for FY 2075/76, business registration certificate and Self-declaration letter of not being ineligible up to the submission along with the bids as per BDS.
